Volunteer understands that this Release discharges Love INC from any liability or claim that the Volunteer may have against Love INC with respect to any bodily injury, personal injury, illness, death, or property damage that may result from the Volunteer's service with Love INC, whether caused by the negligence of Love INC or its officers, directors, staff or agents. Volunteer understands that Love INC does not assume any responsibility for financial assistance or other assistance, including, but not limited to medical, health, or disability insurance in the event of injury or illness. Volunteer hereby assumes the risk of injury or harm in volunteer service with Love INC and releases Love INC from all liability for injury, illness, death, or property damage resulting from volunteer service.
